## 1. CALL TO ORDER

Linda Kroeger called the meeting to order at 6:01 P.M.

### 2. ROLL CALL

Ms. Egbert called roll and a quorum was present.

#### 3. REVIEW OF BUDGET DOCUMENT

Ms. Heath then went over the budget document. She said that this budget had a simple budget, at this time it has one purposes and that is to collect tax revenues that are transferred to the City to cover sewer debt. She then called attention to budget message and noted mistake in the second paragraph. The limitation to the contribution to the sewer fund was set at approximately 13 Million and it is actually 9 Million.

The budget for tax revenue is \$417,000. Limited expense in the URA \$8,000 of that is an administrative fund. The Expenditure budget is \$452,000 which balances with the revenues when combined with the beginning fund balance. There was a 17% increase in revenues in 2019. The transfer to the city was reduced to \$400,000 from \$480,000 from last year, because

we don't know what to expect due to COVID-19. This puts the beginning fund balance this year at \$43,975.

Ms. Taylor inquired if it has been determined what the duration of the Urban Renewal Agency is? Ms. Taylor noted in the plan it only goes through 2023-24. Ms. Heath noted it also states or 9 million dollars which she estimates to be 2031-32. Ms. Taylor noted that is states "whichever comes first" the date or the dollars. Ms. Taylor stated she felt it is something that should be clarified because of the potential impact to the budget.

Ms. Koreger stated if there is no additional questions then she would entertain a motion.

**MOTION:** Todd Waters moved, Terry Dawson seconded to approve the Urban Renewal Agency Budget for Fiscal Year 2020-21 and recommend it to Urban Renewal Agency for adoption. The motion passed unanimously. 10:0
